CRITERIA FOR MEMBERSHIP ON THE BOARD OF DIRECTORS

All Board members must meet the following criteria. In assessing the candidate's qualifications, the following criteria should be considered in the context of the needs of the Board.

Personal characteristics to be sought in candidates for the Board:

- A positive and supportive attitude.
- Well regarded in the community, with a long-term, good reputation for highest ethical standards.
- Good common sense and judgment.
- Managerial experience.
- An inquiring mind.
- An independent, objective, candid, yet constructive approach.
- Cooperative and collaborative spirit with a group conscious mind.
- Considerate of diverse opinion and does not dominate to the exclusion of others.
- A strategic perspective, an awareness of the dynamics of change and the need to anticipate and capitalize on opportunities.
- A positive record of accomplishment in present and prior positions.
- If on another board or boards, has an excellent record for preparation, attendance, participation, interest, and initiative.
- Business and/or professional knowledge and experience applicable to organization goals and other management issues.
- The time, energy, interest, and willingness to become involved in the organization and its future.

Added specific considerations for candidates:

- Consideration shall be given to candidates without regard to race, color, religion, gender, or national origin.
- The Board will seek qualified candidates for board membership from a variety of backgrounds, including candidates of gender and racial diversity.
