- A strategic perspective, an awareness of the dynamics of change and the need to anticipate and capitalize on opportunities.
- A positive record of accomplishment in present and prior positions.
- If on another board or boards, has an excellent record for preparation, attendance, participation, interest, and initiative.
- Business and/or professional knowledge and experience applicable to organization goals and other management issues.
- The time, energy, interest, and willingness to become involved in the organization and its future.


## Added specific considerations for candidates:

- Consideration shall be given to candidates without regard to race, color, religion, gender, or national origin.
- The Board will seek qualified candidates for board membership from a variety of backgrounds, including candidates of gender and racial diversity.
